## CONDITIONS OF ENTRY

Entries are open to Mission Arts members & residents of the Cassowary Coast.



1. All works sold will be subject to commission of 25%.
2. All hung works must not be more than 1.5 square meters in total area. [For example 1000mm x 1500mm including frame].

**Please note: Flat mounting D rings to be at least 6cm from the top of the frame and wire shall be fixed for hanging.**

3. Sculpture and other 3-dimensional works must fit through a standard door when assembled (900mm x 2000mm), must not weigh in excess of 25kg and must not have any dimension greater than 2000mm. This will include any supports if supplied.
4. Original works of clay, glass, mosaic, wood, and/or metal will be accepted.
5. Each artist may submit THREE works only. Diptychs and triptychs and series will be entered and offered for sale as one work (above size limitations apply).
6. All entered works must have been completed within 12 months of this entry date and must not have been previously exhibited at Mission Arts.
7. To enter, completed and signed entry forms must be received by Mission Arts at the Centre or by post to PO Box 286 Mission Beach QLD 4852 no later than **2pm on Friday, 21 August 2020** with a non-refundable entry fee.
8. The inclusion, display and exhibition of any work shall be at the sole discretion of Mission Arts.
9. If Mission Arts is unable to exhibit an artwork appropriately [for any reason] the artwork may not be included in the Exhibition and the entry fee will be refunded to the Artist.
10. On delivery: All entries must have completed '**Artists Labels**' attached to the back of the work, with name, address, contact phone number, title and selling price of the work [inclusive of 25% commission] and any specific display requirements **CLEARLY** stated. Whilst special requests by individual artists will be taken into consideration, Mission Arts reserves the right to display works at their discretion. No late changes will be accommodated. No negotiations will be entered into.
11. Entries should be accompanied by an artist profile or insight statement of no more than 30 words to provide further insight into the artist's background or the inspiration/motivation for the work. These artist statements may be exhibited alongside the artwork to provide gallery visitors with additional insight to the artist and/or the work.
12. Entries must be delivered to Mission Arts, MARCS Park, Mission Beach 4852 in person or by courier at the artist's expense between **10am and 2pm on Saturday, 29 August 2020 and/or Wednesday, 2 September 2020**. Where the Artwork is late, is not delivered free of all charges, or if paperwork is incomplete, the artwork will be ineligible for inclusion in the exhibition. Artwork delivery outside these specified dates/timeframes must be arranged in advance and is subject to volunteer availability.
13. The exhibition will be open from Friday, 4 September – Tuesday, 29 September [inclusive].
14. All entered works should be offered for sale; the sale price shall apply and shall remain fixed for the duration of the exhibition. Works that are not offered for sale may be accepted at the discretion of the Exhibition Committee. The artist's entry fee will apply in all cases. All works entered must be available for display for the duration of the exhibition.
15. By entering, the artist consents to images of their works being reproduced and their biographical information and/or photograph being used by Mission Arts and their agents for promotion of the exhibition, without additional compensation.
16. At the conclusion of the exhibition, all unsold works must be collected from Mission Arts **between 10 am and 2pm NO LATER THAN Friday, 2 October 2020**. If works are to be returned by courier, this must be arranged by the artist or purchaser at the artist or purchaser's expense.
